t is my privilege to review the highlights of the year. As usual, doing so is very heartening. My report reflects the contributions of the Special Interest Research Groups (SIRGs), my colleagues on the Executive and individuals who have taken on particular responsibilities. In all this we have been guided by our Council. The Council Meeting in Taipei in June was helpful and productive.

First and foremost, Lisa Wang organised and staged an excellent Inaugural Congress of IASSID-Asia Pacific in June, 2005. There was a strong scientific programme from the region, the venue and hospitality arrangements were of the highest quality and all aspects of presentation were utterly professional. The Congress was completely successful in its aim to bring together researchers from the region and provide a forum for exchange of their work. The congress abstracts are being published in the *Journal of Policy and Practice in Intellectual Disabilities*. The second Asia Pacific conference will be in Singapore in 2009.

IASSID has now successfully launched regional conferences in Europe and Asia Pacific. Henny Lantman, Marian Maaskant and Wil Buntinx are in the home straight in their organisation of the Second IASSID-Europe Conference, to be held in Maastricht in August. (A Message from the President – Continued)

SIRG meetings are an established part of the annual calendar too. The Aging SIRG met in Dortmund last year and will meet this year in April in Toronto. The Physical and Mental Health SIRGs held their second joint meeting in Melbourne last September. The Profound and Multiple Disabilities SIRG met in Bruges in October. The Quality of Life SIRG is also planning to meet in Canada this coming April, in Vancouver, and the Employment Affinity group is organising a Roundtable in April in St Petersburg. The Executive and Council are conscious that, as the number of IASSID events increases and we advance our truly worldwide identity, then the demand from countries in Eastern Europe, Asia, Africa and South America for support to attend our meetings will increase. IASSID provided a grant to support scholarships for the Asia Pacific meeting but we are aware that it will be necessary to broaden the base of such sponsorship to allow the participation of delegates from developing countries to increase as we would like. For example, we are keen to use the next World Congress in Cape Town as a means to promote our field throughout Africa. I would be happy to hear from any members with suggestions of potential grant givers for this purpose.

Our agreement with the WHO has been renewed. IASSID will support the WHO's development of an international atlas on intellectual disabilities where it can. Tangentially related to this, Eric Emerson is leading an editorial team to produce a special issue of the *Journal of Policy & Practice in Intellectual Disabilities* on "Intellectual Disability Policy and Practice in Low and Middle Income Countries". Anyone interested should note the call for contributions in the next issue of *JPPID*.

Publication is an important arm of our activity. The Quality of Life SIRG sponsored a special issue of the *Journal of Intellectual Disability Research* (2005, **49**, 695-811), following the example two years ago of the Family SIRG and their double issue on family research (2003, **47**, 215-399). A number of the plenary addresses from the World Congress in Montpellier were published in the *Journal of Applied Research in Intellectual Disabilities* (2005, **18**, 279-344).

My sincere thanks go to everyone who has contributed to IASSID's growing impact during 2005. I hope you like the new logo.

2nd International Congress of IASSID-Europe Bridging Research, Policy and Practice

The 2nd International Congress of IASSID-Europe will be held at the University of Maastricht, Maastricht, the Netherlands. We hope to welcome 450 participants at this exciting congress.

Registration

Registration is now open. The early registration fee is applicable until April 30, the late registration closes at July 15. Special registration fees are available for people with ID, IASSIDmembers and students.

Programme

The congress will start with a plenary opening session, and a welcome reception at the Government building near the Maas river. The general format of the conference will be that of a maximum of 80 sessions, with four presentations per session on a specific theme with ample time allowed for discussion. Besides, poster presentation session will be organized. The congress will end with a plenary closing session. We are happy to announce that we received over 450 abstract submissions for both oral presentations and poster presentations. Contributors will receive notifications of acceptance before March 15.

ASSID, serving members primarily in Australia, New Zealand, and the South East Asian region, has recently conducted its 40th annual conference, at Auckland in New Zealand. The theme of the conference was "*Out of the ordinary: creativity, co-operation, collaboration*", and was convened by Ms Fran Hartnett, with many thanks to her hardworking committee and to Dr Patricia O'Brien, formally of the University of Auckland and now at Trinity College Dublin, for initiating much of the groundwork and early organization of the conference.

The 2006 Australasian conference is to be held at Canberra, Australia's national capital, 5th - 8th September, with the theme: *"Risk & Resilience: Hope for the Future"*. Key Note Speakers already confirmed include: Dr Stuart Todd (UK), Dr Levan Lim (Singapore), Professor Jeff Sigafoos (USA), Professor Tony Shaddock (Australia), and Professor Gwynyth Llewellyn (Australia). The annual ASSID Journal Editor's Prize for 2005 was awarded to Dr Judith Cockram (Centre for Social Research, Edith Cowan University), for a paper titled *Justice or differential treatment? Sentencing of offenders with an intellectual disability* (published in Volume 30, Issue No. 1, 2005; pp. 3-13).

The annual ASSID Australasian Research Prize for 2005 was awarded to Dr Nick Hagiliassis, Ms Hrepsime Gulbenkoglu, Mr Mark Di Marco, Ms Suzanne Young (all of "Scope", Victoria) & Prof Alan Hudson (RMIT University, Melbourne) for their paper titled *The Anger Management Project: A group intervention for anger in people with physical and multiple disabilities* (published in Volume 30, Issue No. 2, 2005; pp. 86-96).

The annual ASSID Research Award for 2005 was granted to Dr Robyn Wallace, a physician in private practice in Queensland, for a proposal titled: *An investigation into the prevalence of coronary artery disease risk factors among ageing adults with intellectual disability*. In 2004, ASSID introduced a new category of membership, *Fellow of ASSID*, to recognise the 'exceptional and significant contribution to the field of intellectual disability, with broad impact, sustained over many years'. In 2005, the title of *Fellow of ASSID* was conferred on Professor Trevor Parmenter, Mr Eddie Bartnik and Mr Robert Martin.

Professor Robert Schalock Awarded Doctor Honoris Causa by Universidad de Salamanca

On March 14th, at the Paraninfo of the Historic Building of the University of Salamanca (Spain), the Academic Ceremony of investiture by the Universidad de Salamanca of Professor Robert Schalock as Doctor Honoris Causa took place. The Institute on Community Integration (INICO) proposed Dr. Schalock receive the maximum academic award of the University of Salamanca based on his international leadership role in the field of intellectual and developmental disabilities, and for his continuous support to the activities organized by INICO. Professor Miguel Verdugo, director of INICO, defended the nomination of Schalock in the Act.

When Schalock received the award, after giving his personal speech to the audience, stated that "The Honorary Doctorate from the University of Salamanca represents my past achievements but also provides me with the inspiration and motivation to continue in the future to mentor future leaders in the field, and to be an integral part of the field of disabilities in our joint efforts to enhance the quality of life of those persons whom we serve, interact with, and support".

Prof. Schalock is a scientist of worldwide prestige, who has spent all his life devoted to teaching and research in the improvement of the quality of life of people with disabilities. He is the author of many publications on this subject. His latest publication is a book, co-authored by Val Bradley and Jim Gardner, dealing with the implementation of the concept of quality of life in individuals, organizations, communities, and systems.

Likewise, Prof. Schalock is committed to the AAMR and its work, and he is on a number of their task forces and committees including those devoted to: developing an Adaptive Behavior Assessment Instrument and a Children's Supports Intensity Scale.

Information about this fund will be up on the web-site shortly, together with an application form for those wishing to apply for research grants under the programme. All research projects so funded will be asked to give a presentation in Cape Town of their study and its findings.
